This Endorsement Changes The Policy. Please Read It Carefully.

In consideration of no change in premium, it is understood and agreed that any property damage coverage in the Homeowners Policy (HO3-4/91) under Section I: Property Coverages for Coverage A: Dwelling, Coverage B: Other Structures and Coverage C: Personal Property is excluded for losses caused directly or indirectly by an aircraft owned by or in the care, custody or control of the insured.
